

**RESOLUTION NO. 17-43**

**A Resolution of the City Council of the City of Whitefish, Montana, revising water and wastewater service rates and policies.**

WHEREAS, § 69-7-101, MCA, grants the governing body of a municipality the power and authority to regulate, establish, and change, as it considers proper, rates, charges, and classifications imposed for utility services to its inhabitants and other persons served by municipal utility systems; and

WHEREAS, § 7-13-4304(4), MCA, requires that the water and sewer rates and charges established by a municipality be as nearly as possible equitable in proportion to the services and benefits rendered; and

WHEREAS, § 7-13-4307, MCA, requires that the rates and charges established by the governing body of a municipality for the services and facilities afforded by its sewer and water system be sufficient in each year to provide income and revenues adequate for the payment of the reasonable expense of operation and maintenance and the expenditures for depreciation and replacement of its system, as determined by the governing body; and

WHEREAS, § 7-13-4308, MCA, allows the governing body of a municipality to change and readjust from time to time its water and sewer rates and charges provided the aggregate of such rates and charges are sufficient to meet the requirements of § 7-13-4307, MCA; and

WHEREAS, the City of Whitefish recently completed a Comprehensive Water and Wastewater Rate Study involving a detailed Cost of Service Analysis (COSA) for each utility; and


WHEREAS, the rate study recommended to increase water and wastewater utility service rates as follows to cover the expense of operation and maintenance, and provide for necessary capital improvements:



WHEREAS, as required by § 69-7-111, MCA, public notice of the City's proposed revisions to water and wastewater service rates and policies was published on August 16, August 23 and August 30, 2017, proper notice was mailed to persons served by the City at least seven (7) days and not more than thirty (30) days prior to the hearing, and the Montana Consumer Counsel was given proper notice of the hearing, and

WHEREAS, at a lawfully noticed public hearing on September 5, 2017, after receiving public comment and reviewing a staff report recommending changes, and having considered the expense of operation and maintenance as well as the need for capital improvements, the City Council reviewed the recommended increases in City water and wastewater rates and found them to be reasonable, necessary, and as nearly as possible equitable in proportion to the services and benefits rendered.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Whitefish, Montana, as follows:
